1. Creating Space For You CIC: Commitment to your safety

Our trainee coaches are dedicated to maintaining a safe space where you can freely explore your goals and challenges and have time to reflect. Their focus is on safeguarding the physical, emotional, and mental well-being of all clients.

2. What Safeguarding Means

Safeguarding is Creating Space For You CIC's promise to have the appropriate systems and processes in place to protect individuals from harm, abuse, or neglect. In this context, our trainee coaches are here to support your safety and wellbeing, respecting your confidentiality while ensuring a secure environment.

3. Special Note on Safeguarding Children

While the focus for our trainee coaches is primarily on adults, we are all committed to the safety of all individuals involved. Whether or not a child is present during sessions, if there are any concerns involving a minor, we will handle these with the utmost care, adhering to safeguarding standards for children as well as adults.

4. If You Have a Concern

If you ever feel unsafe or have concerns relating to harm to yourself or anyone else, please tell your coach. Here's what will happen if you do:

- We Listen and Support: Your coach will listen attentively and with empathy.
- Respectful Action: If action is needed, we will aim to discuss this with you in the first instance unless it is not safe to do so. We will contact appropriate safeguarding professionals if it's essential to ensure safety.

5. Confidentiality and Privacy

Your privacy is a priority. We will only share safeguarding information with relevant people if it is absolutely necessary to protect your safety or the safety of others. Our full Confidentiality and Privacy policies are available on our website.

6. Continuous Learning

Our trainee coaches have access to training in safeguarding practices for adults. This ensures that we follow the best practices to create a safe environment for everyone.

Your Privacy and Data Protection: We at Creating Space For You CIC care about your privacy and require our trainee coaches take great care in handling your personal information.

Summary Complaints Procedure for Coachees

Creating Space For You CIC Commitment to Listening and Improving: We're dedicated to ensuring our trainee coaches provide a positive and supportive coaching experience. If you have any concerns or are unsatisfied with any part of your coaching experience, this procedure outlines how to share your feedback with us.

1. Our Approach to Feedback and Complaints

We take all feedback seriously and view it as an opportunity to learn and improve. Whether your concern is small or significant, we encourage you to let us know so that we can address it promptly and fairly.

2. How to Make a Complaint

If you have a concern or wish to make a complaint, please follow these steps:

- Step 1: Speak with Your Coach Often, concerns can be resolved quickly through open communication. You're welcome to discuss your issue directly with your coach, who will listen and work with you to resolve the matter.
- Step 2: Escalate to the Program Supervisor, Charlie Mitchell If you feel your complaint isn't resolved after speaking with your coach, or if you prefer not to discuss it with them, please reach out to the coaching program's supervisor, Charlie Mitchell: charlie@starseedparenting.org. They will review your concern impartially and work toward a solution.

3. What to Expect After Making a Complaint

Once a complaint is submitted:

- Prompt Acknowledgment: We will acknowledge your complaint within five business days.
- Investigation and Response: The program supervisor Charlie Mitchell will investigate your concern and respond within 10 business days, providing a solution or further steps.
- Resolution: If the issue is complex and requires more time, we will keep you informed of the progress and estimated resolution time.

4. Confidentiality and Respect

Your complaint will be handled with care and discretion. We respect your privacy and will only share information as needed to address the concern appropriately.

5. Additional Support and Next Steps

If a satisfactory resolution cannot be reached within the organisation, you may wish to contact the Association for Coaching (AC) for further guidance. The AC provides additional support and guidance for clients within the coaching profession.
